Environmental Compliance Report – Todd Melanson

A document titled "Environmental Compliance Manager's Report, dated July 21, 2021, was distributed to the Board. Mr. Melanson summarized his report which covered:

PFAS6 – A graph was presented, tracking PFAS6 sampling results in Meadow Brook3, Crooked Spring, Riverneck, and Smith Street water treatment plants, covering the period from July 2020-June 2021. The 2nd quarter 2021 averages were Crooked Spring (20), Riverneck (14), Smith Street (7.80), and Meadow Brook 3 which continues to increase above the MCL. MB3's numbers may be due to the amount of rainfall runoff we have received recently.

PILOT STUDY – The Pilot Study on the raw and finished waters is 50% complete. Completion date has been extended until September 13th. RAW WATER – The Purolite IX resin has been replaced with CalRes IX resin for the remainder of the study. FINISHED WATER – The Purolite, CalRes and GAC are still operating.

DEP – The DEP has indicated that lab results need to be back to the Districts in time for them to be reported to the DEP in a timely manner.
